Historical Context

- Since 2007, GSFC has calculated initial student eligibility for the HOPE Scholarship and Zell Miller Scholarship programs.
 - Over 700 public and private Georgia high schools submit transcripts each year to support this effort.
 - GSFC has received almost 2.5M transcripts during this time and has determined eligibility for 1.17M high school seniors.
- The 83 HOPE-eligible postsecondary institutions have been solely responsible for the calculation of a student's on-going HOPE eligibility since the inception of the HOPE program – the first 25 years.

- In 2017, GSFC was asked to lead the initiative to create CHECS... the College HOPE Eligibility Calculation Service. CHECS creates a shared responsibility!
- Very first meeting with leadership from OPB, USG, TCSG and GICA was March 29, 2017.
- First work meeting with System and College stakeholders (JAD Meeting) was May 12, 2017.

- The <u>College HOPE Eligibility Calculation Service</u> (CHECS) is designed to provide a centralized HOPE GPA calculation system for the <u>academic</u> eligibility of HOPE Scholarship, Zell Miller Scholarship, HOPE Grant, and Zell Miller Grant students attending HOPE-eligible postsecondary institutions (PSIs) throughout the state of Georgia.
- CHECS will provide a GAfutures view for students to check their HOPE/Zell Miller Scholarship or Grant statuses.



Purpose of CHECS

- Centralize the process for determining HOPE academic eligibility at the postsecondary level and ensure standardization
- Reduce compliance findings
- Improve the ability to track transfer and transient students
- Utilize GAfutures to improve communication with individual students regarding their continued HOPE eligibility

- The calculations will include the HOPE GPA, Checkpoints, Attempted Hours and Paid Hours for the students.
- CHECS only addresses academic eligibility, not other program eligibility requirements as defined in the Program Regulations.
- CHECS uses a set of GPA and hours calculation business rules developed according to current program regulations.



- Go Live: Effective Fall 2018, the HOPE-eligible PSIs are required to submit student course-level transcript data through CHECS for the calculation of academic eligibility for HOPE/Zell Miller Scholarship or Grant programs.
 - Georgia Military College will be the first college to submit Fall 18 transcript data around November 7.
- The calculated HOPE GPA with Checkpoint and Hours information will then be provided to the PSI who will use the GPA, along with other eligibility criteria, to make future HOPE award determinations.
- The calculated HOPE GPA with Checkpoint and Hours information will be made available to the student through the student's GAfutures user account.

A couple of notes...


- HOPE eligible PSIs must report courses taken at their institution
- Do not report courses taken at another HOPE eligible institution effective Fall 2018
- Transient courses taken at a HOPE Eligible institution are reported by that institution
- Courses taken at a non-HOPE Eligible Institution are reported by the HOPE Eligible Institution the student is attending or transferring to for upcoming term
 - All attempted degree level courses must be reported

What CHECS is NOT!

- CHECS does not remove the college from the GPA/Checkpoint calculation process
- Hands Free
- A Magic Bullet for all your HOPE problems
- A Perfect Solution for all Scenarios

CHECS Terms... the Saga!

- Null or 000000 GSFC originally had a bug in the program and returned you null/empty values for the 3 term fields in the file. The USG ITS solution converted those null values to 000000.
- Summer 2018 Bug fixed! But this field was longer than the some solutions allowed (so some of these records rejected).
- Summer 18 Format currently being returned


Data Transmission: Private Institutions

- PSI Submits Historical Snapshot files through SURFER's Upload File process
 - Pipe Delimited, CSV
- PSI Submits Transcript Data files and CHECS Request files based on your Data Transmission selection in the Institutional Profile
 - Manually through SURFER's Upload File process
 - SFTP (requires some initial configuration)
- Return Files:
 - Readable Reports and Pipe Delimited Files will be provided in the Institution's SURFER Inbox or via SFTP


Data Transmission: TCSG Colleges

- All CHECS files are exchanged between the TCSG System Office and CHECS
- No CHECS files will be sent directly from a college or received by a college
- CHECS Historical Snapshot TCSG will submit the Snapshot files for each TCSG College
- **CHECS Transcript Data** TCSG will submit the Transcript Data files for each TCSG College at the end of each term after the grades are final. Any grade changes will be automatically identified and reported to CHECS via the transcript file.
- CHECS Request Data The following students will be automatically extracted from each college's Banner system by TCSG and included in the daily CHECS Request Data file.
 - 1) All students with current or future term admissions application. (Note: Receipt of admissions application only, official admittance is not required for this process.)
 - 2) All students with current or future term registration.
 - 3) All students with HOPE or Zell Miller Grant or Scholarship awarded for the current or future aid year.
- **GPA Calculation/Checkpoint** Provided by CHECS (*Automated file import process into Banner and displayed via TCHECS web application*.) This file is created as the result of TCSG submitting either the CHECS Request file or the Transcript Data file. Data from this file is used for awarding of HOPE/Zell Miller Scholarship and Grant programs.



CHECS Historical Snapshot Record/File



Historical Snapshot Record/File

- The Historical Snapshot (Snapshot file or US file)
 - CHECSUS18LSN.TXT sent to CHECS through SURFER Upload File
 - Return: only an Error file: CHECSDS provided through SURFER Inbox
- Reports the student's HOPE/ZM status (including GPA, Attempted Hours, Quality Points, and Most Recent Checkpoint and Eligibility through the Most Recent Term of Enrollment - with academic history)
- CHECS will use the Snapshot to begin HOPE/Zell Miller Scholarship or Grant Calculations for students with academic history before Fall term 2018
 - Do not include students with only dual or joint enrollment courses prior to high school grad or home school completion

- Always submit status through Summer 2018 or last term enrolled if it occurred prior to Summer 2018
- Never includes status beyond Summer 2018
 - CHECS performs the calculations starting Fall term 2018 and after
- Provided by a HOPE Eligible Institution, student's status, through Summer term 2018 or most recent term of enrollment whichever is most current, used as a starting point to continue calculating academic eligibility
- May be provided by file or manually in the CHECS Calculation Record

Include and not to Include

- Include students:
 - Receiving (eligible) HOPE or Zell Miller Scholarship or Grant,
 - Previously received HOPE or Zell Miller and could regain eligibility, and
 - Not currently eligible but could gain eligibility with time

• Exclude students:

- 1) Permanently lost eligibility,
- 2) Only has courses while in high school,
- 3) Will never be eligible,
- 4) No postsecondary academic history (no attempted hours beyond high school) prior to Fall term 2018

- For Testing Purposes: Pilot I Group: Historical Snapshot records are through Spring term 2017
- For Testing Purposes: Pilot II Group: Historical Snapshot records are through Fall term 2017
- For Testing include a number of students that reasonably represent your total student population

Note: if your institution's test Snapshot file with a few errors is used for testing:

Records with errors will not load

Be sure you understand the errors, you may see them again from the Go Live Snapshot File

- Live: CHECS Calculations start with Fall term 2018
- All Historical Snapshots are through Summer term 2018
 - or most recent term of enrollment
- Scholarship Snapshots
 - Attempted hours prior to Fall term 2018 must be reported through a Snapshot record
 - Must include all previously attempted hours including from other institutions (HOPE eligible and non-HOPE eligible)
- Grant Snapshots
 - Must include all HOPE Grant Hours

Yes, new Snapshot records will still be needed after Fall 2018

- Case 1: Snapshot submitted in Fall 2018, however, a grade change has occurred on student record for course prior to Fall 2018
 - Recalculate the updated Snapshot and resubmit
- Case 2: Fall 2019 student transfers to USG college after attending college in Alabama in 2017-18 and 2018-19
 - College calculates Snapshot through Summer 2018
 - College submits Transcript Data for terms after Summer 2018

CHECS Historical Transcript File



- The Historical Transcript Data File
 - File Name: CHECSUHLSN.TXT
 - Not required for testing
 - Sent to CHECS through SURFER Upload File
 - No Return provided
 - No edit checks preformed on the data loaded as is
- Provided to support the (Go Live) Historical Snapshot records provided
- Reports the course and grade info for the terms the student attempted credit hours through Summer term 2018
 - Submit data which is available within the SIS
- The Historical Transcript Data File never includes courses after Summer term 2018

- Historical Data (Summer 2018 and earlier): The Transcript Data file layout should also be used to submit student-level historical data to CHECS. NOTE: File name is different than transcript file CHECSUH###.TXT
- In the best case scenario, the PSI will submit transcript data records for all the students that are submitted as part of the Historical Snapshot file.
- While these data, Summer 2018 and earlier, will not be used to perform the GPA/Checkpoint calculations, they will be helpful for students and PSI administrators to reference as we transition to CHECS.

- For example, if a student transfers to your institution and you have questions about a student's HOPE eligibility, you'll be able to view the student's historical snapshot and individual transcript data records within the CHECS module
- PSIs are only expected to submit student/course-level transcript data on students that are a part of your current Student Information System (SIS)
- This also includes course-level data located in your SIS that was taken at non-HOPE-eligible institutions

- Historical course-level records (Summer 2018 and earlier) will be used for informational purposes only, to help explain the GPA calculations to students and for research purposes
- There will be no compliance audits of the historical course-level detail provided to GSFC by PSIs

CHECS Transcript Data Record/File



Transcript Data File/Record

- The Transcript Data record/file (Transcript or TD file)
- File name: CHECSUTLSN.TXT
- Required for Testing
- Submit files using SURFER, SFTP or Ethos-Banner
- Return files: Errors: CHECSDE & GPA/Checkpoint File
- Reports course and grade info for a specific term
 - Going live will typically submit the Transcript Data file at the end of the term after grades are processed
 - Yes, may have to submit an updated Transcript Data file when something changes with the course(s)

- Include and not to Include
- Include students:
 - Receiving (eligible) HOPE or Zell Miller Scholarship or Grant,
 - Previously received HOPE or Zell Miller and could regain eligibility, and
 - Not currently eligible but could gain eligibility with time
- Exclude students:
 - 1) Permanently lost eligibility previously
 - 2) Only has high school courses,
 - 3) Will never be eligible,
 - 4) No academic history (no attempted hours beyond high school) prior to Fall term 2018

Transcript Data File/Record

- For Testing Purposes: Pilot I Group: Transcript Data Files for Summer term 2017, Fall term 2017 and Winter/Spring term 2018
- For Testing Purposes: Pilot II Group: Transcript Data File for Spring/Winter Term 2018 only
 - Not to include previous terms
- CHECS will preform Calculation as of the end of Spring
 - PSI verify it is correct

- HOPE Eligible PSIs must submit student/course-level data for courses taken at non-HOPE-eligible institutions beginning with Fall 2018
- For example, if the student took courses at Auburn University, the CHECS reporting PSI must submit those courses/hours via the transcript data file or manually add the courses in CHECS

- Credit hours must be reported in the same "Term Type" as they appear on the transcript report of the PSI where the coursework was taken
- GSFC will perform any needed conversion from quarter to semester or semester to quarter
- For example... if the student went to an out-of-state college on the quarter system, and the student attended Winter, Spring & Fall quarters, the CHECS reporting PSI must submit those hours as quarter hours for Winter, Spring & Fall quarters so that CHECS will calculate the GPA & Checkpoints correctly.

- Transient, Cross Registration & ARCHE Programs: Beginning with Fall 2018, if a student is taking courses under any of these types of agreements, the courses/hours must be submitted to CHECS by the PSI where the course was taken – provided they are a HOPE-eligible PSI
- If the PSI is not HOPE-eligible, then the home institution must submit/enter the courses into CHECS

- Term Sequence: It is very important for the PSI to submit complete academic records for students at the time that the GPA/Checkpoints are calculated.
- For example, if a student attends Spring, Summer and Fall of 2020, the PSI must enter/submit these records in the order that they occurred or else the GPA and Checkpoints will be calculated incorrectly.
- If the records for all three terms are submitted at the same time, that is ok, but they cannot be submitted individually out of order with GPAs/Checkpoints calculated at each submission.

- STEM Weighting: For CHECS to accurately award the additional weight for all eligible STEM courses, it is imperative that the course details be submitted to CHECS exactly as they appear on the transcript.
- CHECS will then compare the record to the STEM Weighted Courses Directory (approved course list) and will apply additional weight, if any, per program regulations.

- Submitting New Records vs Entire History each Term: At the end of each term, the PSI must submit new courses to CHECS to be included in the GPA and Checkpoint calculations.
- It is considered a best practice that the PSI only submit new courses to CHECS, and not resubmit prior-term courses, since courses taken previously will have already been submitted and included in the student's calculation record.
- If prior term courses are resubmitted to CHECS, it will slow down the processing of the entire CHECS system. However, if a PSI submits courses that were previously submitted to CHECS, the system will read those records, determine that they exist already, and then will ignore them.

- Course-Level Changes: The Transcript Data file can be used to submit course-level record changes as needed for the following fields: Course Title, Grade, Credit Hours, Learning Support, Dual Enrollment and Joint Enrollment.
- To do so, resubmit the Transcript Data file course record to CHECS with the updated information and CHECS will replace the originally submitted record. The OPEID, Term, Subject, Course Number and Section must all be the same as previously submitted for the change to take effect.
- The PSI that submitted the original record must be the PSI to update the record. An institution cannot change another institution's record.



Transcript Data File/Record

- Add, Edit, and Count Toward Degree (CTD) functions for courses can be submitted in a Transcript Data file
- Deactivate a course can NOT be submitted in a Transcript Data file (must be entered manually)

Request File



CHECS Request File

- CHECS Request File
- Filename: CHECSUR###.TXT
- Not required for testing
- Sent to CHECS through SURFER, SFTP, Ethos
- Return file is the GPA/Checkpoint File
- Edits:
- Purpose is to request from CHECS the current GPA and Checkpoint data on file for the student(s)
- For example, if the PSI has 50 students accepted as transfers for Fall term 2019 and wants to request their HOPE GPA and Checkpoint status from CHECS
 - Load those 50 students into the CHECS Request data file and submit to CHECS
 - CHECS will provide the PSI with a GPA/Checkpoint file that contains the most recent GPA and Checkpoint data on file for those 50 students

CHECS Request File

- PSIs can submit the CHECS Request data file as often as they like with any combination of students that are needed
- This file does not load any transcript data into CHECS and it doesn't trigger any GPA or Checkpoint calculations
- The results file only returns to the PSI any data that are known in CHECS for the given set of students

GPA/Checkpoint File



GPA/Checkpoint File

GPA/Checkpoint File (Results file)

- Filename: CHECSDC###.TXT
- For testing, provided when an acceptable test Transcript data file and Snapshot file are received
- Sent to PSI through SURFER, SFTP, Ethos (based on Data Transmission option)
- This file is created as the result of the PSI submitting either the CHECS Request file or the Transcript Data file
- This file is designed to be loaded into the PSI Student Information System (SIS) to assist with future awarding of HOPE/Zell Miller Scholarship and Grant programs

GPA/Checkpoint File

- Each time the PSI submits a CHECS Request file or the Transcript Data file, CHECS will return all data that has been submitted and processed for the given set of students that are in CHECS
- The file contains fields for the most recent Scholarship and Grant Checkpoints/GPA data as well as fields for the current GPA (which may be more recent than the last Checkpoint GPA)
- For example, if a student enrolled in Spring term and then again in Fall term, and the End of Spring checkpoint was conducted, and no checkpoint was conducted at the end of Fall, the file for this student would include the End of Spring checkpoint/GPA as well as the current GPA inclusive of the Fall hours

End of Term Process

- Submit the Transcript Data file for the term after your Academic grades have rolled or are processed
 - Keep in mind: 83 institutions have different end of term dates
 - GSFC SAS will contact institutions that have not submitted a Transcript Data file representative of their institution in a timely manner
- Upcoming term HOPE and Zell Miller Scholarship and Grant Invoices will not be paid until the CHECS Transcript Data records are received an processed
 - Invoices will be held with status of CHECS Requirement Not Met

 - Grades only given for AP or IB courses not needed since high school courses are not to be reported

CHECS Terms

- Submit terms in which the HOPE GPA Calculation would be performed
 - Fall, Spring, Summer Semesters

 - CHECS allows term equivalencies three years in advance
 - Currently, CHECS terms are thru Summer Term 2021

- Each Spring time, scheduled for March
 - Each PSI must review Institutional Profile screens, make on-screen updates as needed, complete onscreen confirmation info is up-to-date
 - Institutional Data update as needed
 - Contacts update as needed
 - Terms add new terms as the institution approves them and set the equivalencies
 - Grades add new grades as the institution approves them and set the equivalencies
 - Note: term and grade files are not used going forward. Those files were only for the initial setup in early 2018.

CHECS Pending Courses

- When pending courses exist on a student's record, then a transcript data file is submitted for the student
 - If the pending course and Transcript Data file is from the same PSI, the PSI will receive an error in response to the Transcript Data file

CHECS Count Toward Degree

- Count Towards Degree (CTD)
 - Certificate/diploma-level courses to be counted toward a degree
 - Student completed 20 hours in a diploma program that are part of his HOPE Grant GPA, those hours do not automatically count towards a degree-level program
 - PSI must mark the individual diploma-level courses as CTD in CEHCS or a Transcript Data file
 - Courses are then included in the HOPE Scholarship calculation

CHECS Count Toward Degree

- PSI marks a "Y" (Yes) in the CTD field and lists the Count Towards Degree Effective Term Code (the term at which the course is being included as part of the degree program – not the term it was taken)
- CHECS will count this course in the Scholarship GPA/Checkpoint Calculation from this effective term forward
 - The OPEID, Term, Subject, Course Number, and Section must all be the same as previously submitted for the CTD to take effect

CHECS Transfer and Transient Students

- Courses taken at a HOPE Eligible Institution
 - Courses attempted Fall term 2018 and after must be reported as Transcript Data by the HOPE Eligible Institution where the course is taken/attempted
 - Courses attempted prior to Fall term 2018 must be reported in the Snapshot
 - The Institution submitting a Snapshot must include all attempted hours (at own institution and previous institutions)
- Courses from a Non HOPE Eligible Institution

Scholarship Eligibility from high school


