Subject: GSFC Operations and Communications Plan/Update

The Georgia Student Finance Commission is continuing operations during these uncertain times and remains committed to providing services to Georgia's students, high schools and eligible postsecondary institutions. We have implemented multiple social distancing strategies for the protection of our employees and continue to expand our online offerings to provide the services and information that our customers need.

We are working with GADOE, USG, TCSG and GICA regarding current situations for Spring term 2020. We are examining potential scenarios that may affect student academic eligibility for the state aid programs, including HOPE and Zell Miller Scholarship and Grant programs, in conjunction with statutory and regulatory requirements. Additionally, we are considering options for student borrowers of the state loan programs. In this early stage of the COVID-19 situation, we are considering the options available and seeking guidance from State leadership.

As updates are available, we will communicate through GAfutures and additional Dear Colleague Letters.

We want to provide as much consideration and flexibility as possible so that you can continue to serve students and partner with Georgia's high schools, home study programs and eligible postsecondary institutions.

### Online services
