Subject: Dual Enrollment funding Program Update

Dear Colleague:

GSFC announced in 2019 a Dual Enrollment funding application project to bring much needed enhancements to the application process. As reported March 6, 2020 (DCL 2020-08), the new online student application launched for all students enrolling in Dual Enrollment coursework starting Summer term 2020 and beyond. At this time, over 20,000 students have completed an application.

The Dual Enrollment Single View access was released on May 18, 2020. The Single View is part of the Dual Enrollment module for high schools, home study programs and postsecondary institutions to process their students' applications for the new year starting with Summer term 2020. The Single View includes new Dual Enrollment funding requirements from the passage of House Bill 444 and program regulations.

Within the Dual Enrollment module is a "Single View" for high school and postsecondary professionals to process online student applications effective Summer term 2020. Today, the Single View has been released so that processing may begin.

- The new GAfutures High School Functions (HSF) menu was made available on March 3, 2020 with the new Dual Enrollment Dashboard and Resources modules. It is available to high school professionals with granted access by their District or School Administrator and home study program parents/guardians/officials with access granted through their GAfutures account setup.
- HSF's Dual Enrollment module now includes the Single View which is accessible through the Dashboard by clicking on an individual student's Dual Enrollment funding application.
- The GAfutures Postsecondary Functions (PSF) menu for eligible postsecondary institutions was updated March 3, 2020 with the new Dual Enrollment module Dashboard. It is available to postsecondary professionals with granted access by their Institutional Administrator.
- PSF's Dual Enrollment module now includes the Single View which is accessible through the Dashboard and clicking on individual student's application.
- Documents are being posted to HSF and PSF Resources to provide information about the changes to Dual Enrollment funding program and the new application.
