MESSAGE FROM THE INTERIM PRESIDENT


The Georgia Student Finance Commission (GSFC) is the state education agency responsible for giving students financial choices and access to higher education by administering nearly 20 state and federal scholarship, grant and student loan programs. GSFC also promotes FAFSA completion and financial literacy by providing free financial aid workshops and trainings. Each year we work with students, parents, high school counselors and our postsecondary partners to increase the number of Georgians with access to an affordable postsecondary education. In FY 2017, GSFC's efforts to help create a more educated Georgia did not wane. Below are a few highlights from the year:

- ► GSFC provided more than \$764 million in scholarships, grants and loans to over 234,000 Georgians to help pay for higher education expenses.
- ➤ Nearly 36,000 students from 1,900 public and private high schools and home school programs participated in **Dual Enrollment** (Move On When Ready). In total, over 400,000 college credits were earned by Dual Enrollment students, allowing them to get a head start on completing a college credential.
- ➤ GAfutures.org celebrated its first year as Georgia's premiere resource helping students across the state plan for college. Over the course of FY 2017, GAfutures had almost 1.5 million visits and more than 304,500 accounts created. New functions and information continue to enhance the user experience and better prepare Georgians to access education beyond high school.
- GSFC's K-12 and postsecondary outreach representatives conducted almost 2,200 events and visits at high schools, colleges and community organizations across the state. More than 91,000 students and their families learned about federal and state financial aid programs and application processes.
- ➤ Thirty-four new school districts enrolled in the **REACH Georgia** program for the 2017-2018 school year. As a result, almost 1,200 Scholars will be participating in the needs-based scholarship and mentorship program. The REACH Georgia Foundation also raised \$734,000 in support of the program during FY 2017.
- ▶ More than 15,378 **Path2College 529 Plan** accounts were opened in FY 2017. Georgia's official college savings plan saw assets under management grow to more than \$2 billion, resulting in a significant reduction in fees. Families utilized nearly \$118 million in qualified withdrawals for higher education purposes.
- ► GSFC produced the first edition of *Georgia's College Connector*, a print publication serving as an A-Z resource on Georgia's financial aid programs and the college planning process.

At GSFC, we are proud of our mission and history of providing financial choices to Georgia's students since 1965. We will continue to build on our successes and increase our efforts to ensure students and their families have the information and resources to confidently plan, apply and pay for college. Our successes would not be possible without the support of many. Thank you to our Board of Commissioners, staff, and statewide partners for your ongoing commitment and dedication to our programs and the students of Georgia.
